The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

## ARTICLE I

The name of the corporation (Corporation) is WYNN HAVEN ANIMAL CLINIC, INC.

#### ARTICLE II

The period of its duration is perpetual.

#### ARTICLE III

The purpose is to engage in the business of a veterinary hospital and/or any business as permitted under the laws of the United States and the State of Florida.

The maximum number of shares this Corportation is authorized to issue is One Hundred (100), all of which shall be Common Shares.
