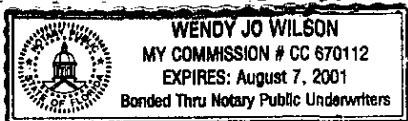
1. Bruno Gagnon is the President of ADVANCED DRYWALL, INC., a Florida corporation, (hereinafter "Corporation").
