Article II - Duration

This corporation shall exist perpetually, commencing with the effective date of September 21, 1998.

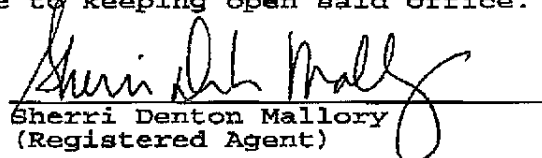
