**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME AND MAILING ADDRESS**

The name of this corporation is Cantonment Three, Inc. and the mailing address of this corporation 516 Lakeview Road, Unit 8, Clearwater, FL 33756.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.

**ARTICLE III - PURPOSE**

This corporation is organized to include the transaction of any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes as presently enacted and as it may be amended from time to time.
