ARTICLES OF INCORPORATION CLAYTON WOODS, INC.

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, and desiring to form a corporation under the laws of the State of Florida, hereby certifies as follows:

ARTICLE I - NAME AND ADDRESS

The name of the corporation is Clayton Woods, Inc. and the address of its principal place of business is 1275 Lake Heathrow Lane, Heathrow, Florida 32746.

ARTICLE II - DURATION
