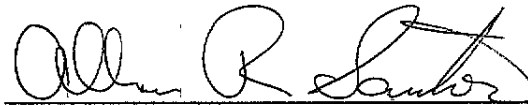
## ARTICLE EIGHT

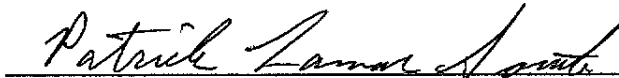
