Pursuant to the provisions of 607.1006 of the Florida Business Corporation Act (the "Act"), the corporation hereinafter named does hereby adopt the following Articles of Amendment:

1. The name of the corporation is MAB Acquisition Corp.
2. Article FIRST of the Articles of Incorporation of the corporation is hereby amended to read in its entirety as follows:  
  
"FIRST: The corporate name for the corporation (the "Corporation") that satisfies the requirements of Section 607.0401 of the Act is Metro Auto Body, Inc."
3. The date of adoption was September 23, 1998.
