

ARTICLES OF INCORPORATION

OF

A1A SIGN CITY, INC.

ARTICLE 1

NAME

The name of this corporation is A1A SIGN CITY, INC.

ARTICLE II

DURATION

This corporation shall exist perpetually.

ARTICLE III

PURPOSE
