ARTICLES OF INCORPORATION OF OAKBROOK CONSTRUCTION OF N. FLA., INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of this corporation shall be Oakbrook Construction of N. Fla., Inc.



Article II Principal Office and Mailing Address
