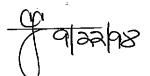

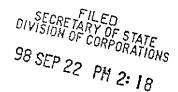

ARTICLES OF INCORPORATION



OF

WD BRAND PRESTIGE STEAKS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation shall be WD Brand Prestige Steaks, Inc.
