The undersigned, who is duly licensed to practice the profession of medicine in the State of Florida, desires to form a Professional Corporation for the purpose of rendering medical services, and adopt the following Articles of Corporation:

ARTICLE I

NAME

The name of this corporation is:

ARTICLE II

DURATION

This Corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.
