

**ARTICLES OF INCORPORATION
OF
ORLANDO'S TOP SERVICES, INC.**

THE UNDERSIGNED, acting as sole incorporator of **ORLANDO'S TOP SERVICES, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**
