ARTICLE I – NAME and PRINCIPAL PLACE OF BUSINESS

The name of the corporation is A. ROBIELUE INSURANCE & INVESTMENT INC. and its principal place of business shall be located at 5171 W. Oakland Park Blvd., Suite P203, Lauderhill, FL 33313.

ARTICLE II – DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III- PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV – CAPITAL STOCK

This corporation is organized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

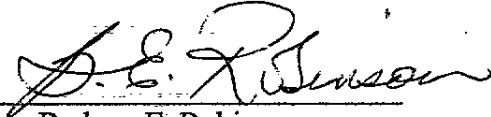
