ARTICLE I

The name of this corporation shall be **FAP HOLDINGS, INC.**

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The maximum number of shares of capital stock which the corporation is authorized to have at any time is **ONE HUNDRED (100)** shares of common stock at \$1.00 par value.

ARTICLE IV

The corporation shall have perpetual existence.

ARTICLE V

ARTICLE VI

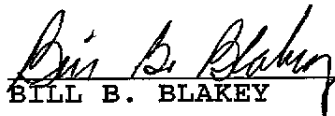
The initial Board of Directors shall consist of one (1) member. The number of Directors may be increased or decreased from

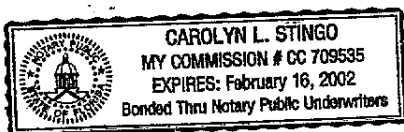

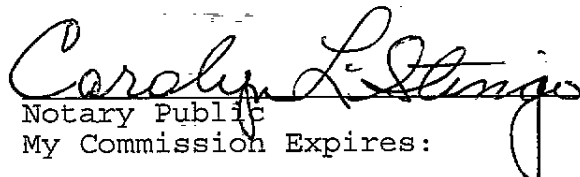

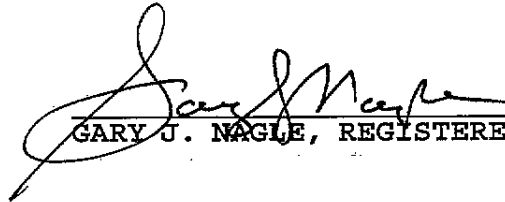
