ARTICLE I - NAME

The name of this corporation is: SPECIALTY LIGHTERS & CLASSIC CERAMIC, INC., with the principal place of business located at: 7535 DADELAND BLVD., MIAMI, FL. 33158.

ARTICLE II - PURPOSE

This corporation shall have perpetual existence and may engage in any and all lawful business under the laws of the United States and the State of Florida.
