The undersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

**ARTICLE I**

The name of this Corporation shall be: **Y2K SYSTEM CONSULTANTS, INC.**, and its initial mailing address shall be: 3119 Manatee Avenue West, Bradenton, Florida 34205. The initial address of the Corporation's principal office shall be: 8104 12th Avenue N.W., Bradenton, Florida 34209.

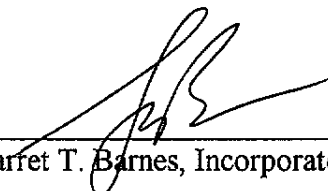
