The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a professional service corporation (the "Corporation") pursuant to Florida Statutes § 621.01 et.seq., as follows:

1. NAME

The name of the Corporation is:

2. TERM OF EXISTENCE

The date when the corporate existence shall commence shall be September 8, 1998, and the Corporation shall have perpetual existence thereafter.

3. PURPOSE

The purpose for which the Corporation is organized shall be to engage in the practice of medicine within the State of Florida, and to take all actions that are necessary or proper in connection with the practice of medicine.

The initial Board of Directors shall have three members whose names and addresses are as follows:




