The undersigned incorporator to these Articles of Incorporation hereby forms a professional service corporation under Chapter 621 of the Florida Statutes as follows:

ARTICLE I

Name

The name of this corporation is DAVID C. SELF, II, P.A.. The corporate mailing address is 1645 Palm Beach Lakes Boulevard, Suite 1150, West Palm Beach, Florida 33401.

ARTICLE II

Term of Existence

The date when corporate existence shall commence shall be the date of the filing of these Articles of Incorporation by the office of the Secretary of State of the State of Florida, and the corporation shall have perpetual existence thereafter.

ARTICLES III

Nature of Business

This corporation is organized to engage in the practice of law.

ARTICLE IV

Capital Stock

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which shall be designated Common Shares.

## ARTICLE V

### Initial Registered Office and Agent


