Name

The name of the corporation is CHAVES-SUNRISE CORP.



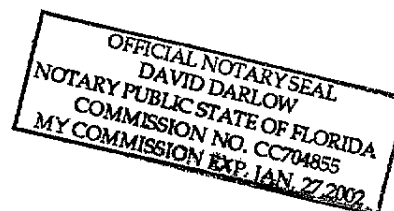


