ARTICLES OF INCORPORATION

I, RICHARD N. MALLAR, do hereby incorporate myself
for the purpose of becoming a corporation for profit under
Florida law.

ARTICLE I

The name of the corporation is: GULFCOAST BUSINESS
FURNITURE, INC..

ARTICLE II

This corporation is organized to engage in the wholesale
sale of business furniture of all kinds. The corporation may
also conduct other related functions and enterprises not
prohibited by law.

ARTICLE III

The aggregate number of shares which this corporation
may issue is One Hundred Thousand (100,000), all of which
shall be common shares with a par value of One Dollar (\$1.00)
per share. Each shareholder has full preemptive rights to
purchase any shares held or owned by other shareholders of
the corporation. Each shareholder of any class of stock of
this corporation has full preemptive rights to purchase any
unissued shares of the corporation.

Each shareholder of any class of stock of this corporation
shall also be entitled to full preemptive rights to purchase
any corporate securities carrying rights of subscription to
and/or acquisition of, any unissued or treasury shares.

ARTICLE IV

The business of the corporation will be managed by the shareholders.

ARTICLE V

The corporation shall have perpetual existence.

ARTICLE VI
