# ARTICLES OF INCORPORATION OF PROSPECTIVE MANAGEMENT, INC.

ON SESTING TO THE SERVICE OF THE SER

ARTICLE I - NAME

The name of this corporation is PROSPECTIVE MANAGEMENT, INC. The principal address of said corporation is 3624 SE 18<sup>th</sup> Avenue, Ocala, FL 34471.
