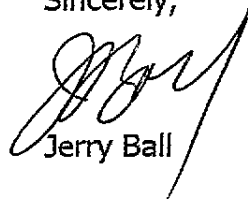

ARTICLES OF INCORPORATION

ARTICLE ONE: Name

The name of the corporation is Jerry Ball Enterprises, Inc.

ARTICLE TWO: Principal Office

The principal office of the corporation shall be located at 708 Dorado Court, Brandon, Florida 33511.

ARTICLE THREE: Stock

The number of shares the corporation is authorized to issue is one thousand (1000). There shall be one class of shares, which is common, and each share shall have a par value of ten cents (\$0.10). The rights of each shareholders shall not vary as to relative rights and preferences among shares. All or any part of said shares may be issued by the Corporation from time to time and for such consideration as may be determined upon or fixed by the Board of Directors, as provided by law.

ARTICLE FOUR: Registered Agent

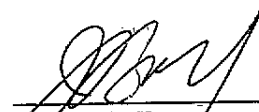

ARTICLE EIGHT: Effective Date

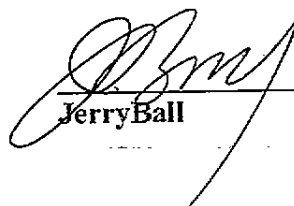
The effective date of the corporation shall be the date of filing of the Articles of Incorporation by the Department of State.
