### ARTICLES OF INCORPORATION

#### ARTICLE I

The name of the corporation is: TRI-STATE OF SOUTH FLORIDA, INC. The mailing address of the corporation is: 1570 Madruga Avenue, Suite 211, Coral Gables, Florida 33146.
