ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

1. NAME: The name of the Corporation is OGDEN INTERNATIONAL INC.

2. DURATION: The period of its duration is perpetual.
