# ARTICLES OF INCORPORATION

The undersigned, Acting as incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

# ARTICLE I

The name of this Corporation is:

POPI'S, INC.

# ARTICLE II

The purpose for which this Corporation is initially organized is for establishing and operating a restaurant business and for the transaction of any and all lawful businesses for which a corporation may be incorporated under the laws of the State of Florida.

# ARTICLE III

The Corporation shall have the authority to issue 1,000 shares of common stock having a par value of One Dollar (\$1.00) per share. There shall be only one class of shares.

# ARTICLE IV

The initial street address of the registered office of the Corporation in the State of Florida shall be 815 8<sup>th</sup> Avenue West, Palmetto, FL 34221, and the initial registered agent at such address shall be KALLIOPI E. AMERES.

#### ARTICLE V

The Corporation shall have two (2) Directors . The number of directors may be either increased or diminished from time to time by By-Laws, but shall never be less than the minimum number required by law. Directors need not be shareholders or residents of the State of Florida.
