ARTICLES OF INCORPORATION OF J & E PLASTERING, INC

The undersigned incorporator, for the purpose of forming a business corporation under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation shall be:
