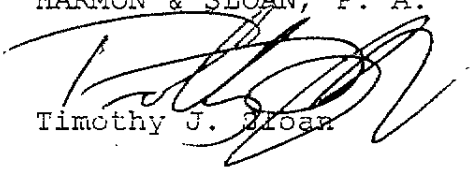

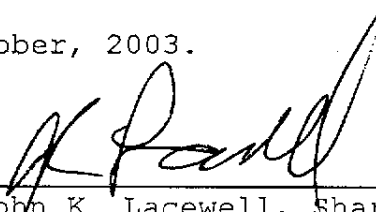
I. ARTICLE I is hereby amended to read as follows:

ARTICLE I - NAME

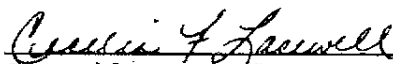
The name of this corporation is Lacewell Enterprises, Inc.
