

ARTICLE 1

The name of the Corporation is:

MATHEWS SERVICES, INC.

ARTICLE 2

The term of existence of this corporation shall be perpetual. This corporation shall be deemed to commence its existence on the acceptance of these Articles of Incorporation by the State of Florida.


