It seems that Habana Vending Corporation Document # P98000083008 still shows as "inactive" status.

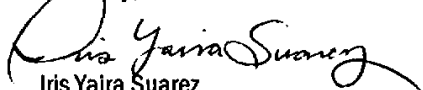
