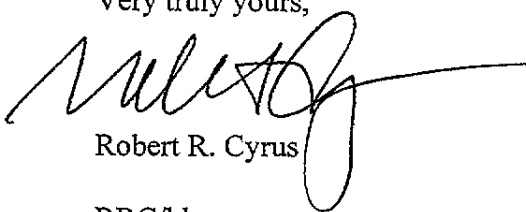

**ARTICLE I. NAME** **EFFECTIVE DATE**

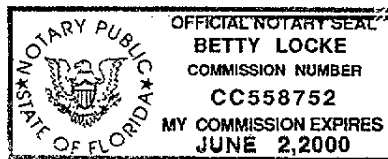
