Please find enclosed our completed Corporation Reinstatement form along with a check in the amount of \$750. Kindly accept this letter as explanation for our lapse in corporate renewal. Unfortunately, we have found ourselves on the recipient-end of very poor legal representation. You will note that Robert I. Claire, Esquire has been our official registered agent for this and other corporations and/or entities. Mr. Claire's office had led us to believe that his office had been maintaining and updating necessary filings and records for our entities. We had no reason to believe that any problems existed until we were financing new office copiers and had the bank run the typical searches for the company. Only when the bank notified us of the lapse did we come to realize that nothing had been done to keep the corporation active. In fact, we moved our place of business and residence from Boca Raton to Miami several years ago which helps explain why the state had no way of contacting us directly outside of Mr. Claire's office.
