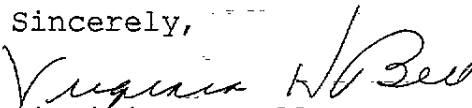

There will be 100 shares of common stock with no par value held by the three officers.

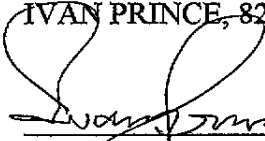
