ARTICLES OF INCORPORATION
(Professional Corporation)

The undersigned incorporator desiring to form a professional corporation under Chapters 607 and 621 of Florida statutes, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the Professional Corporation shall be Frederick G. Klepes, Jr., D.D.S., P.A.

ARTICLE II. PURPOSE

The purpose for which this corporation is organized is to practice the profession of dentistry.

ARTICLE III. DURATION

The corporation shall have perpetual existence.

Corporate business shall be managed by the shareholders of the corporation, rather than by a board of directors.

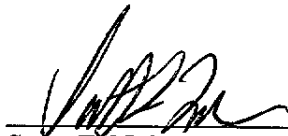
ARTICLE IX. PRINCIPAL OFFICE

ARTICLE X. PRINCIPAL PLACE OF BUSINESS


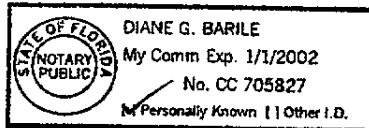
