I, the undersigned, hereby form a corporation for profit under the general incorporation laws of the State of Florida, and in accordance with the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be:

Network Industries, Inc.

and its principal place of business shall be in the County of Dade, Florida, with the right to change and move said principal place of business and establish such other offices and places of business within or without the State of Florida as may from time to time be deemed proper.

ARTICLE II

The general purpose and nature of the business of this corporation is to engage in any activity of business with any or all powers for any or all purposes determined to be convenient or necessary as permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The total authorized capital stock of this corporation shall be one (1) share of Common Stock with no par value.

All such stock shall be issued fully paid and non-assessible at and for such consideration, whether the same be cash, services fixed rendered, or otherwise, and upon such terms and conditions as may be fixed and subject to these articles herein.

ARTICLE IV

The amount of capital with which this corporation shall be not less than 100 Hundred Dollars (100.00).

ARTICLE V

The corporation shall have perpetual existence, unless earlier terminated by due and proper legal procedure.
