ARTICLES OF INCORPORATION

The undersigned incorporator to these Articles of Incorporation is a natural person competent to contract and for a corporation under the Laws of the State of Florida, and does certify that he has become a corporation under and pursuant to the following Articles of Incorporation.

ARTICLE I. The name of the corporation shall be

ARTICLE II. The general nature of the business to be transacted by this corporation is to engage or transact in any or all lawful activities or business permitted under the laws of the United States of America, The State of Florida and any other state, country, territory or nation.

ARTICLE III. The corporation shall have all of the powers given to it by the laws of the State of Florida, now or hereafter, and specific powers herein enumerated shall not be construed as a limitation upon the powers of this corporation.

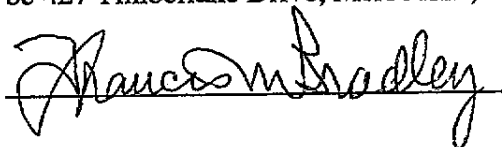
