ARTICLES OF INCORPORATION OF TOURIST DOC., P.A.

The undersigned, for the purposes of forming a corporation under Chapter 621 of the laws of the State of Florida. Hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be:

TOURIST DOC., P.A.

The address of the principal office of this corporation shall be 1373 Tadsworth Terrace, Heathrow, Florida 32746, and the mailing address of the corporation shall be the same.

ARTICLE II. DURATION

The term of existence of the corporation is perpetual.

ARTICLE III. NATURE OF BUSINESS

This corporation may engage in every aspect of the business of rendering the same professional services to the public that a medical doctor duly licensed under the laws of the State of Florida, is authorized to render.
