ARTICLES OF INCORPORATION OF BILLY THOMPSON, M.D., P.A.

THE UNDERSIGNED, acting as sole incorporator of BILLY THOMPSON, M.D., P.A. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME

The name of the corporation is BILLY THOMPSON, M.D., P.A.

ARTICLE II PURPOSE

The purpose of the corporation is the operation of a family medical practice.

ARTICLE III SHARES

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, one cent (\$.01) par value per share.
