The undersigned, acting as incorporator of a corporation under the Florida Business Corporation act, adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation is Express Cash & Loan, Inc.
2. The period of its duration is perpetual.
3. The purpose is to engage in any action or business permitted under the laws of the United States and Florida.
4. The corporation shall have the authority to issue 5,000 shares of common stock, all of one class, \$1.00 par value each.

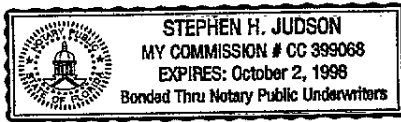
