

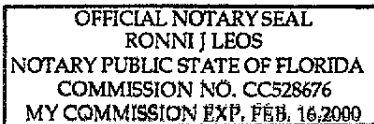
it is offered to others.


