ARTICLE IV


CAPITAL STOCK

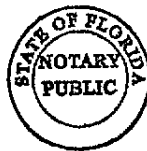


