## MINUTES OF THE SPECIAL MEETING OF THE SHAREHOLDERS OF SUNVENTURES OF WALTON COUNTY, INC.

A special meeting of the shareholders of Sunventures of Walton County, Inc., a Florida corporation, was held at 5 Clifford Drive, Shalimar, Florida, on the day of December, 1998, pursuant to the waiver of notice attached.

The following shareholders were present in person or by proxy:

In Person

James Murray acted as chairperson and and as secretary of the meeting. The chairperson declared that all shareholders of record received notice of the special meeting and its purpose, all of the shareholders were present in person or by proxy, and that all had executed a waiver of notice of the meeting. The chairperson then announced the purpose of the meeting was to consider the dissolution of Sunventures of Walton County, Inc. and to adopt a plan of liquidation of the assets.

A discussion ensued and the following resolutions were unanimously adopted by the board of directors and shareholders of Sunventures of Walton County, Inc.:

WHEREAS, the shareholders, upon recommendation of the directors of Sunventures of Walton County, Inc., have determined that it is advisable and beneficial for the corporation that it be liquidated and dissolved; and

WHEREAS, the shareholders must and do hereby adopt a plan of liquidation and dissolution of Sunventures of Walton County, Inc.;

RESOLVED, that the following plan of liquidation is adopted to assemble and marshal the assets of Sunventures of Walton County, Inc., to pay or make adequate provisions for the debts of Sunventures of Walton County, Inc., and apportion the remaining assets among the shareholders according to their respective interests:

1. Sunventures of Walton County, Inc. shall be liquidated pursuant to the Internal Revenue Code and Section 607.1401 of the Florida Statutes.

- 2. Sunventures of Walton County, Inc. will distribute all of its property and assets effective as of December 31, 1998.
- 3. All liabilities and obligations of Sunventures of Walton County, Inc. will be paid or discharged, or adequate provision will be made for them.
- 4. The officers of Sunventures of Walton County, Inc. are authorized to sell or otherwise liquidate all the properties and assets of Sunventures of Walton County, Inc. that they deem necessary or advantageous to facilitate the liquidation.
- 5. The officers of Sunventures of Walton County, Inc. are authorized to do any and all things necessary or convenient to carry these resolutions into effect, including, but not limited to, the following:
  - a. executing any and all instruments of conveyance;
  - b. paying all taxes and fees;
  - c. executing all documents required by law to be filed;
  - d. retaining professional advisors, and
  - e. doing all other things necessary or convenient to effect the dissolution of Sunventures of Walton County, Inc.
- 6. After the provision for, or payment of, the known debts and liabilities of Sunventures of Walton County, Inc., the officers are authorized and directed to distribute the remaining cash or other assets of Sunventures of Walton County, Inc. to the shareholders of record according to their respective rights and interest in exchange for their shares in Sunventures of Walton County, Inc.

There being no further business to come before the meeting, it was, upon motion duly made, seconded, and unanimously carried, adjourned.
