## ARTICLE 1 - NAME AND PRINCIPAL OFFICE

The name of this corporation is **BORIS MARINE**, **INC.** The Address of the principal office is 820 N.E. 33<sup>rd</sup> Street, Boca Raton, FL 33431-6130.

#### **ARTICLE 2 - DURATION**

This corporation shall exist perpetually commencing on the date these articles are filed with the Department of State.

#### **ARTICLE 3 - PURPOSE**

This corporation is organized for the purpose of operating a business for providing woodworking services to the general public, and for transacting any or all lawful business permitted by statute.

#### ARTICLE 4 - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock having \$1.00 par value per share.

All unissued shares of stock must be granted with the unanimous approval, of the Board of Directors, prior to their issuance, if at all.

#### ARTICLE 11 - POWERS

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.
