The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act and Section 621.01, et seq. of the Professional Service Corporation and Limited Liability Company Act does hereby certify as follows:

ARTICLE I
Corporate Name and Address

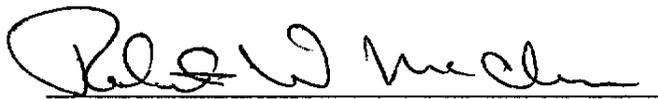
ARTICLE VII

The term of existence of the Corporation is perpetual.

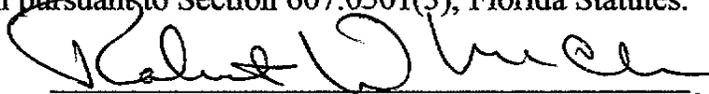
