#### ARTICLES OF INCORPORATION

OF

JJ'S ENTERPRISES, INC. OF LOXAHATCHEE

THE UNDERSIGNED SUBSCRIBER, ACTING AS INCORPORATOR OF A CORPORATION (HEREINAFTER REFERRED TO AS THE CORPORATION), UNDER THE PROVISIONS OF THE STATUTES OF THE STATE OF FLORIDA, DOES HEREBY MAKE, SUBSCRIBE, ACKNOWLEDGE AND FILE THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I
1.1) NAME: THE NAME OF THE CORPORATION IS:

### ARTICLE 2.

2.1) PURPOSES: THE CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES AND OF THE STATE OF FLORIDA.

#### ARTICLE 3.

- 3.1) NUMBER OF AUTHORIZED SHARES: THE AGGREGATE NUMBER OF SHARES OF CAPITAL STOCK WHICH THE CORPORATION SHALL HAVE AUTHORITY TO ISSUE SHALL BE ONE THOUSAND SHARES OF COMMON STOCK OF A PAR VALUE OF ONE DOLLAR (\$1.00) PER SHARE.

WHEN PAYMENT OF THE CONSIDERATION FOR WHICH SUCH SHARES ARE TO BE ISSUED SHALL HAVE BEEN RECEIVED BY THE CORPORATION, SUCH SHARES ARE TO BE DEEMED TO BE FULLY PAID AND NON-ASSESSABLE. IN THE ABSENCE OF FRAUD IN THE TRANSACTION, THE JUDGEMENT OF THE BOARD OF DIRECTORS OR THE STOCKHOLDERS, AS THE CASE MAY BE, AS TO THE VALUE OF THE CONSIDERATION RECEIVED FOR SUCH SHARES SHALL BE CONCLUSIVE

# ARTICLE 4.

# DATA RESPECTING DIRECTORS

- 4.1) INITIAL BOARD OF DIRECTORS: THE FIRST BOARD OF DIRECTORS OF THE CORPORATION SHALL CONSIST OF THREE MEMBERS WHO NEED NOT BE RESIDENTS OF THE STATE OF FLORIDA NOR A STOCKHOLDER OF THE CORPORATION.
- 4.2) NAMES AND ADDRESSES: THE NAMES AND STREET ADDRESSES OF THE MEMBERS OF THE FIRST BOARD OF DIRECTORS WHO SHALL HOLD OFFICE UNTIL THE FIRST ANNUAL MEETING OF STOCK-HOLDERS OR UNTIL THEIR SUCCESSORS SHALL HAVE BEEN SELECTED OR APPOINTED AND HAVE QUALIFIED ARE:

# PROVISIONS FOR REGULATION

#### OF THE INTERNAL AFFAIRS OF

# THE CORPORATION

- 6.1) MEETINGS OF STOCKHOLDERS: MEETINGS OF THE STOCKHOLDERS OF THE CORPORATION MAY BE HELD AT SUCH PLACE, EITHER WITHIN OR WITHOUT THE STATE OF FLORIDA, AS MAY BE PROVIDED BY THE BY-LAWS. IN THE ABSENCE OF ANY SUCH PROVISIONS, ALL MEETINGS SHALL BE HELD AT THE PRINCIPAL OFFICE OF THE CORPORATION.
- 6.2) MEETINGS OF DIRECTORS: MEETINGS OF THE BOARD OF DIRECTORS OF THE CORPORATION, ANNUAL, REGULAR, OR SPECIAL, MAY BE HELD EITHER WITHIN OR WITHOUT THE STATE OF FLORIDA.
- 6.3) BY-LAWS: THE INITIAL BY-LAWS OF THE CORP-ORATION SHALL BE ADOPTED BY IT'S BOARD OF DIRECTORS. THE POWER TO ALTER, AMEND OR REPEAL THE BY-LAWS, OR TO ADOPT NEW BY-LAWS, SHALL BE VESTED IN THE BOARD OF DIRECTORS. THE BY-LAWS MAY CONTAIN ANY PROVISIONS FOR THE REGULATION, MANAGEMENT AND GOVERNMENT OF THE BUSINESS, AFFAIRS AND PROPERTY OF THE CORPORATION NOT INCONSISTENT WITH THE LAWS OF THE STATE OF FLORIDA, OR THESE ARTICLES OF INCORPORATION.
- INTEREST OF DIRECTORS IN CONTRACTS: ANY 6.4)CONTRACT OR OTHER TRANSACTION BETWEEN THE CORPORATION AND ONE OR MORE OF IT'S DIRECTORS, OR BETWEEN THE CORPORATION AND ANY FIRM, ORGANIZATION, ASSOCIATION, CORPORATION OR OTHER LEGAL ENTITY OF WHICH ONE OR MORE OF IT'S EMPLOYEES, OR IN WHICH HE OR THEY ARE OTHERWISE INTERESTED, SHALL BE VALID FOR ALL NOTWITHSTANDING THE PRESENCE OF SUCH DIRECTOR OR DIRECTORS AT THE MEETING OF THE BOARD OF DIRECTORS OF THE CORPORATION WHICH ACTS UPON, OR IN REFERENCE TO, SUCH CONTRACT OR TRANSACTION, AND NOTWITHSTANDING HIS OR THEIR PARTICIPATION ON SUCH ACTION, IF THE FACT OF SUCH INTEREST SHALL BE DISCLOSED OR KNOWN TO THE BOARD OF DIRECTORS AND THE BOARD OF DIRECTORS SHALL, NEVERTHELESS, AUTHORIZE, APPROVE OR RATIFY SUCH CONTRACT OR TRANSACTION BY A VOTE OF A MAJORITY OF THE BOARD OF DIRECTORS PRESENT, SUCH INTERESTED DIRECTOR OR DIRECTORS TO BE COUNTED IN DETERMINING WHETHER A QUORAM IS PRESENT, BUT NOT TO BE COUNTED IN CALCULATING THE MAJORITY NECESSARY TO CARRY SUCH VOTE. THIS PROVISION SHALL NOT BE CONSTRUED TO INVALIDATE ANY CONTRACT OR OTHER TRANSACTION WHICH WOULD OTHERWISE BE VALID UNDER THE COMMON AND STATUTORY

LAW APPLICABLE THERETO.

# ARTICLE 7.

# 7.1) AMENDMENTS TO ARTICLES OF INCORPORATION:


