ARTICLES OF INCORPORATION

The undersigned hereby subscribes to these Articles of Incorporation for the purpose of becoming a corporation under the laws of the state of Florida, by and under the provisions of the statutes of the state of Florida, providing for the formation and liabilities, rights, privileges, powers and immunities of a corporation for profit, and I hereby certify:

ARTICLE I

The name of this corporation is SKULLHEAD TATTOO, INC.

ARTICLE II

This corporation is organized for the purpose of the tattoo and body piercing business, and any and all other kinds of related incidental activities thereto, without limitation, and for the purpose of transacting any and all business and engaging in any activity permitted under the laws of the United States and of the State of Florida.

ARTICLE III

This corporation is authorized to issue seven thousand, five hundred (7,500) shares of one dollar (\$1.00) par value common stock which shall be determined "common shares" with equal voting rights.

ARTICLE IV

Except as otherwise provided by law, the entire voting power for the election of directors and all other purposes shall be vested exclusively in the holders of the outstanding common stock.

#### ARTICLE V

The street address of the initial registered office of the corporation is 1401 S. Military Trail, Ste. G, West Palm Beach, Florida 33415, and the initial registered agent of the corporation at that address is LINDA RUDOLPH.

#### ARTICLE VI

#### ARTICLE VII

This corporation shall have two (2) directors initially, and there shall never be less than (1) director. The initial directors are LINDA RUDOLPH and ROBERT BRIEGEL, both of 1401 S. Military Trail, Ste. G, West Palm Beach, Florida 33415.

#### ARTICLE VIII

The name and address of the person signing these Articles of Incorporation is LINDA RUDOLPH of 1401 S. Military Trail, Ste. G, West Palm Beach, Florida 33415.

#### ARTICLE IX

The shares of capital common stock of this corporation to be issued initially are as follows:

LINDA RUDOLPH - 51 shares  
ROBERT BRIEGEL - 49 shares

#### ARTICLE X

The officers of this corporation shall be LINDA RUDOLPH as President, Secretary, Treasurer, Director and Registered Agent, and ROBERT BRIEGEL as Vice-president and Director.

ARTICLE XI

This corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

ARTICLE XII


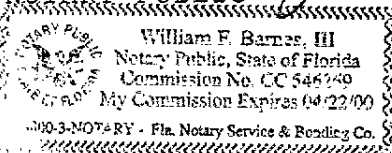
This corporation reserves the right to amend or repeal any provision contained in these Articles, or any amendment hereto; any right conferred upon any shareholder is subject to this reservation.
