

ARTICLES OF INCORPORATION

OF

SUNSHINE CONSTRUCTION SERVICES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be SUNSHINE CONSTRUCTION SERVICES, INC.

ARTICLE TWO: DURATION: The term of existence of the corporation is perpetual.

ARTICLE THREE: PURPOSE: The purpose is to engage in any activities or business permitted under the Laws of the United States and Florida; including but not limited to, heavy equipment construction.

ARTICLE FOUR: CAPITAL STOCK: The corporation is authorized to issue one hundred (100) shares, all of which shall be common shares, no par value.

ARTICLE FIVE: INITIAL REGISTERED OFFICE AND AGENT: The street address of the initial Registered Office of the corporation is 706 Roberts Avenue, Deland, Florida 32724, and the name of the Registered Agent is JERRY A. WHITE, of 706 Roberts Avenue, Deland, Florida 32724.


ARTICLE EIGHT: BYLAWS AND ARTICLES OF INCORPORATION:
