The three referenced corporations were all incorporated on 9/28/98 and Articles of Incorporation were submitted to the Florida Department of State. All are startup corporations, which I anticipate will reach full activity within the next 12-18 months.

The original Annual Report Fee Statements due May 1, 2000 were never received and the second notices were received late. This was due to some extraordinary occurrences within the past 10 months, which are detailed as follows.

My husband passed away on Thanksgiving Day, November 25, 1999 and I have been involved in attempting to straighten out his affairs since then. Also, my elderly aunt took ill in November 1999 and I was travelling between Gainesville and Tampa weekly to take care of her. I was also spending significant time in Tampa because of her condition. Towards the beginning of spring, she became well enough to travel to Michigan - her residence and I drove her there. Several days later she fell and broke her leg and since there were no family members to look after her, I remained in Michigan for the entire summer to care for her. While there, my uncle who was residing in Tampa passed away and was buried in Michigan. Towards the end of the summer, my Aunt was well enough to travel and we began the drive to Florida only to have her become deathly ill, requiring 2 weeks hospitalization in Chicago, and necessitating flying home and leaving the car. After several doctors care she was on the road to recovery and staying at my residence in Melrose where we were preparing to fly north to pack up her automobile and suddenly she expired. The last few weeks I have been involved with her burial, the estate and with the personal representative in Michigan.
