**ARTICLES OF INCORPORATION
OF

The undersigned incorporator hereby forms a corporation under the applicable Florida Statutes, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME AND ADDRESSES

The name of the Corporation shall be:

WILDLIFE JEWELRY, INC.

The address of the principal office of this corporation shall be 100 Doolen Court, #111A, North Palm Beach, FL 33408, and the mailing address of the corporation shall be 1506 St. Louis Street, Springfield, MO 65802.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having \$1.00 par value per share.




