ARTICLE ONE

NAME:

THE NAME OF THE CORPORATION SHALL BE MSR IMPORT AND EXPORT, INC.

ARTICLE TWO

NATURE OF BUSINESS :

IMPORTS AND EXPORTS
THIS CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS
PERMITTED UNDER THE LAWS OF THE UNITED STATES OF AMERICA
AND THE LAWS OF THE ESTATE OF FLORIDA.

ARTICLE THREE

TERM OF EXISTENCE
