## **ARTICLES OF INCORPORATION OF SPIRIT WEAR, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

### **ARTICLE ONE - NAME**

The name of the corporation is SPIRIT WEAR, INC.
